Funding the Free Entitlement in Barnet

Definition

All children are entitled to up to six terms of free early education before reaching statutory school age (the first term following their fifth birthday). Depending on local arrangements for admission to school many children start full time education in school reception classes before reaching compulsory school age. The free entitlement is a guarantee of a free place. It is not a voucher, nor should it be regarded as a parental subsidy. With effect from 1 April 2006, the minimum free entitlement for three- and four-year-olds of 12.5 hours a week was extended from 33 to 38 weeks in all settings. Children become eligible from the term following their third birthday.

Providers in Barnet

The table below shows the range of settings and the number of children (part time equivalent) taking up the free entitlement.

The private sector provides around 60% of the free entitlement in Barnet.

Over a third of local authority nursery classes are in voluntary aided schools (CofE - 8, RC - 6 and Jewish - 7). In the private sector only 25% of settings are known to have a religious affiliation but these are mostly Jewish (27).

Funding

Local Authority and Private Voluntary and Independent (PVI) settings are funded on a different basis at present, but a number of funding and organisational changes are being brought in by the government by April 2010:

- All settings to be funded for the free entitlement on take-up not places
- Increase in free entitlement from 12½hrs to 15hrs per week
- Increased flexibility 15 hour free entitlement to be taken flexibly over a minimum of 38 weeks and a minimum of 3 days per week
- A consistent funding formula for the free entitlement for all settings.

The Early Years Working Group has been set up to agree a consistent funding formula which takes into account the first three points.

Proposed Workplan for the Early Years Working Group

In the plan below, the meetings have been timed to take place a week or so before each main Schools Forum meeting, so that feedback to the Schools Forum will reflect the most recent work of the group.

Four meetings per year are suggested – two in the autumn term and two in the summer term. The spring term is usually very busy with budgeting, but extra meetings can be added if necessary.

The process of developing the single funding formula starts looking at the experience of the pathfinders authorities, and identifying how different providers will manage extra hours and increased flexibility. It then goes on to look at comparative costs in different settings and the main areas the funding formula will need to cover. By this time we should know more about the government's proposals for data collection and their guidance on aspects of funding such as additional educational need and deprivation. We can then carry out modelling, look at alternative formulae and consult all providers. The final proposals will be taken back to the Schools Forum for approval and implementation from April 2010. The final meeting of the EYWG will review the success of the new funding formula.
